Ceste lettre me remist entierement en nature et de là en avant ne pensoys à autre qu'en ce qui me pouvoit donner allegueument d'esprit, m'accroissant santé et forces lesquelles, comme les alloyz recouvrant encors que petit à petit me fust conseillé que je m'eusse à appliquer tous les jours à quelque corporel exercice, pour tant plutost les corroborer, et suivant ce m'appliquay à celluy de tyrer aux armes, auquel passé quelques années m'estoys exercité, et m'en playsois extremement et à cest effect en feiz venir à ma mayson les maistres bataillieurs, avec lesquelz combattoys journellement en presence et soubs conduicte d'un certain Paulo de Paredes un des mellieurs maistres d'armes d'escrime de la court, mesme-ment qui n'agueres avoit enseigné à tyrer aux armes sa propre Majesté et estoit homme fort à droict à toutes sortes d'armes, et me les enseignoit quasi toutes, et ausquelle le plus m'exercitoys estoient à l'espée seule, item à l'espée et dague, item à l'espée, et cappe, item à l'espée et bouclier, item aux deux espées, et sur le tout à l'espée à deux mains qui est un exercice fort apropos pour se desnouer et agiliter le corps, comm' aussi est celluy des deux espées qui ne consistent en autre qu'en de fort belles voltes, qui se font par un fort bel ordre et

2^a Dos tajos, y una estocada y un revez, entrando y saliendo.

3^a Dos tajos, entrando, y dos revezes saliendo.

4^a Tres vueltas de tres tajos entrando, y tres revezes saliendo.

5^c Estocada y tajo entrando y estocada y revez saliendo.

6^a Dos tajos y una estocada vuelta por las espaldas, y un revez entrando y saliendo.

7^a Tres cenidos entrando la vuelta con tajo y otros tres saliendo, y la vuelta un revez, es para hazer plaça.

8^a Tres tajos y una estocada y un revez, y vueltas las espaldas salir de la misma manera, es para una calleja angosta.

9^a Un tajo y una estocada, entrando, y saliendo, es la guarda cappa.

10^a Un tajo cegando, y otro cayendo, y una estocada y con su revez, entrando y saliendo. Es para una plaça redonda.

- 11^a Dos tajos un passo tras otro metiendo el pie yzquierdo primero y volver con estocada y revez, es la Bregua que llaman.
- 12^c Estocada con saccar el pie yzquierdo y un tajo a pie quedo, y otra sacando el derecho con un revez a pie quedo, y las vueltas con revez meneando los pies, es para une calle ancha.

De ces douze reigles depend tout le jeu de l'estoc, ou montant, lequel pour le bien jouer fault estre si adroit, que de les jouer toutes pesles-mesles, les unes parmy les autres, les appliquant selon la disposition du lieu, et les occasions qui s'y trouvent à la main, autrement ne sert de rien d'en scavoir tant seulement les douze reigles par son bel ordre, comme celluy qui peint une belle lettre ou caractere, sans en scavoir les sens, ni l'orthographie d'icelles. Et touchant aux voltes aux deux espées, n'en ay jamais sceu obtenir un seul escrit, encores que le tout s'apprend aussi par ordre et compas redigé en des reigles ou canons, mais croy que la memoire m'en demeurera enpraincte pour à jamais. Par autre costé me delectay aussi grandement à l'estude des horloges, ou quadrans au soleil auquel effect frequentay journelement le devant nommé Docteur Andres Garcia de Cespedes, mathematicien du roy, un homme tres singulier, et tres expert en cest art et science, et de qui j'obtins l'ensuyvant traicté, touchant la fabrique desdits horloges, ou quadrans au soleil....
